## Corel Video Studio X9 is Here!

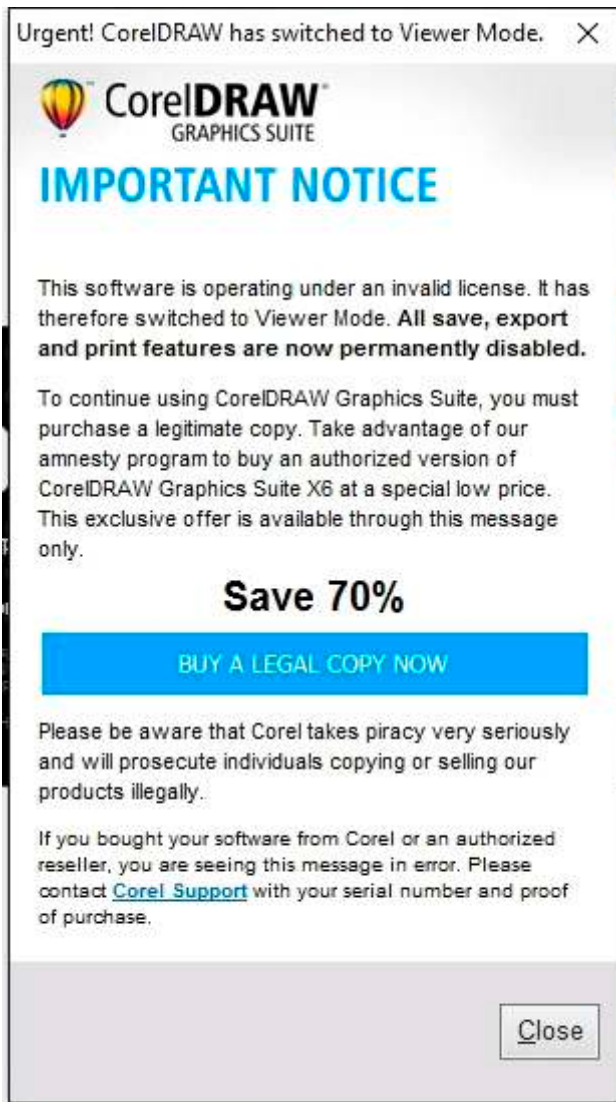

### **Important Notice: This software is operating under an invalid license!**

Have you ever had this wonderful message come up on your monitor as you open up your Corel product?

It's fair enough if in fact you do have an illegal software package on your computer, but most maddening if you have done all the right things, paid your money and now suddenly some time down the track this message appears.

It's also very frightening if you suddenly think that you can no longer save, export or print.

I've had this problem before with one of our computers. As I always have, and pride myself in having fully licensed software, I took it a bit personal. In my case it turned out to be a case of changing machines. An old computer was replaced by a new one and the software reloaded by the computer technicians.

The old machine went off to the computer 'graveyard'. Corel in their wisdom, (admittedly several years later), suddenly presented us with this message. It all got sorted out but you do have to be aware that changing machines can produce problems down the track.

The same problem has hit other members recently. Below, is the response that was received from Corel Support by Lance when he ran into the same problem.

Thank you for contacting Corel Customer Support.

A particular CorelDraw X6 update triggers the anti-piracy campaign to determine illegitimate copies of the software. However, there had been reports that some users who have legitimate licenses had been affected by this and mentioned that they are getting this anti-piracy prompt even though they have valid licenses. It seems that you are one of those users who got affected by this issue and I would like to apologize for the inconvenience that it caused.

This issue can be resolved or corrected by deleting the temporary files and updating your program.

Follow these steps:

1. Delete the temporary files on your machine. Check this article for instructions:

2. Download and install program updates in proper order ( X6.1 Update, followed by X6.4 Update then by X6.4 Hotfix 1). You can download the installers of these updates on this page:
